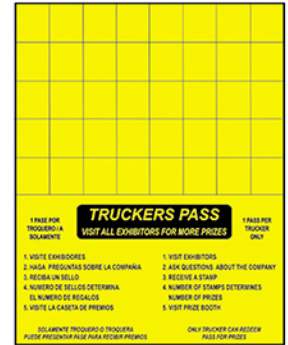


# TRUCKERS PASS

Each Trucker will receive a "TRUCKERS PASS" at time of registration. The Trucker must ask a QUESTION that pertains to the Exhibitors booth/company in order to receive a stamp on the " TRUCKERS PASS " by the exhibitor.

The "TRUCKERS PASS" will then be redeemed by the trucker for prizes. The prizes will depend on the amount of exhibitors they have visited that day.

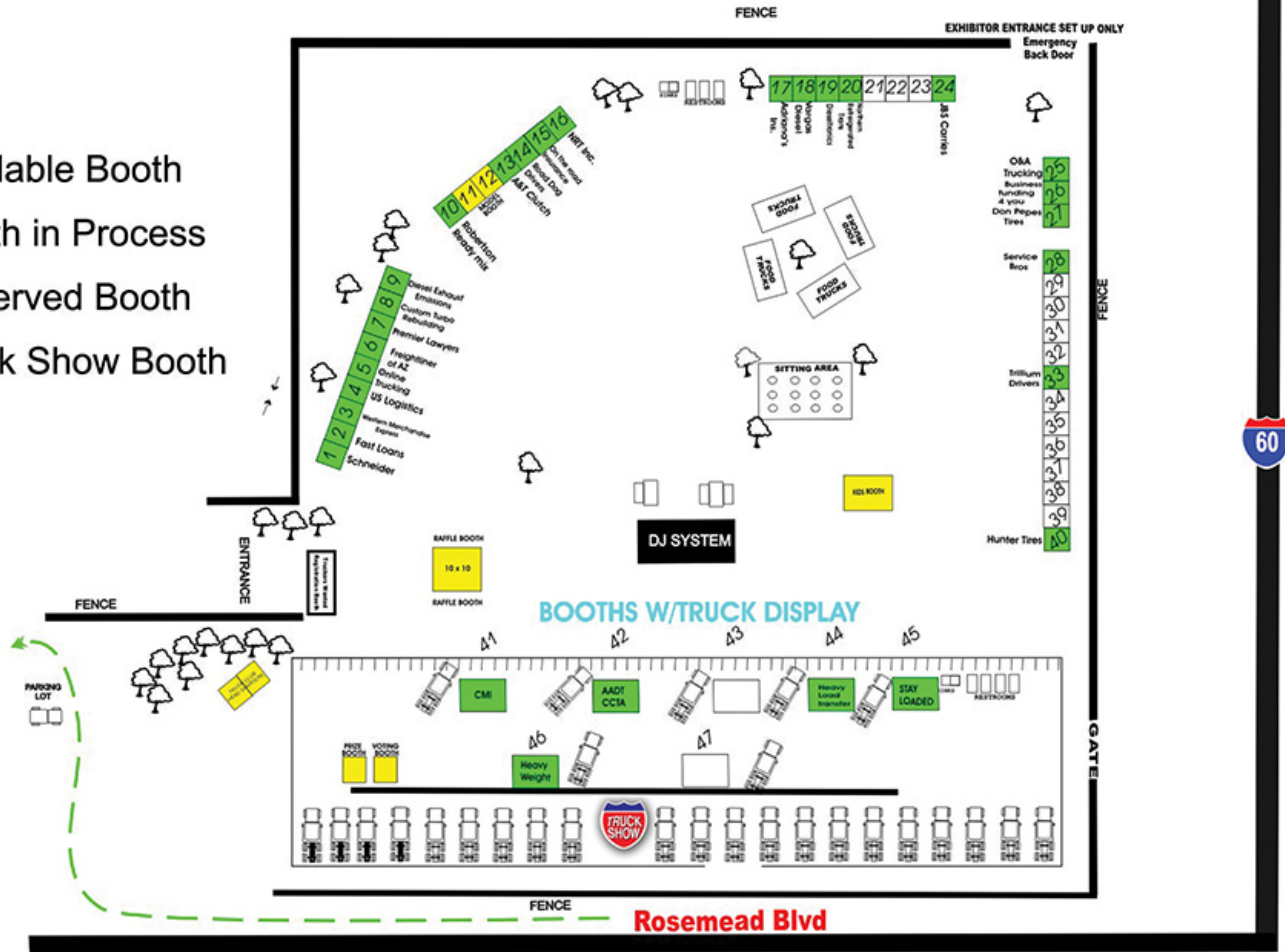

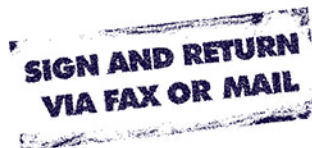

Truckers Wanted Truck Show & Job Fair 2016

- Exhibitors must arrive for set-up between the hours of 7:00a.m. - 9:00 a.m. on event day.  
NO Vehicles will be allowed on show Premises for set up after 9:30am (STRICTLY ENFORCED)  
All Exhibits must be completely set-up for Fire Dept. walk thru by 9:30 a.m.
- Vehicles Will be Allowed onto Show Premises for Loading/Unloading Only
- All Vehicles must leave show Premises Immediately After Unloading
- Exhibitors agree Not to dismantle or vacate their booths before 3:00 p.m.
- NO Vehicles are Allowed on Premises until Show Area is Cleared of Attendees
- Exhibitors are allowed to bring extra equipment if needed.  
(Such as chairs, tables, etc., at no extra charge)
